MDS 3.0 is a critical nursing facility assessment tool that can directly impact resident quality of care, survey outcomes, your publicly posted quality measures and your reimbursement. Make sure you and your staff know how to complete the MDS 3.0 accurately the first time!

This two-day course is the most comprehensive MDS 3.0 training offered in Oregon, and the only class that presents the provider's perspective on this key assessment tool.

- The Care Area Assessment (CAA) Process
