2013 Special Session Appropriation Spending Priorities

Senior Mental Health - \$3.5 million

- \$2.8 million – *Placing geriatric and disability mental health and addiction specialists in all 36 county mental health programs*
- \$700,000 – *Senior mental health training*

Special Needs Transportation – additional \$4 million

- *Enhance funding for elder and disabled transit services*

Caregiver Training - \$3.3 million

- \$1.6 million – *Geriatric medication competency training pilot*
- \$450,000 – *Specialized training to professional and family caregivers on Alzheimer's & related dementias best care practices*
- \$400,000 – *Specialized training for caregivers on challenging behaviors*
- \$500,000 – *Specialized first responder training on Alzheimer's & related dementias*
- \$350,000 – *Enhancing access to caregiver training statewide*

Restoration of Quality Care Fund Sweep - \$1 million

Public Guardianship Program - \$925,000

- *Expansion of State Ombudsman office to manage Public Guardianship program and increase legal assistance*

Data, Research, Pilot Projects - \$1.792 million

- \$750,000 – *re-establish annual reporting for community based care/in-home/nursing facility on data utilization, clinical indicators, and functional status. (OHP R 2.0)*
- \$750,000 - *Develop community based care capacity index and make available to case managers and the public to better plan their long term care needs*
- \$112,000 – *General Assistance study*
- \$30,000 – *Collection and analysis of data on cognitive impairment and caregiving via annual BRFSS report*
- \$150,000 *Cash Oregon grant for technology upgrade*

Personal Incidental Fund (PIF) Increase - \$1.3 million

- Increase nursing facility resident PIF from \$30.00 to \$100.00 (first increase in over 20 years)

Oregon Project Independence - \$3 million

- Initiate SB 870 to expand coverage over younger persons with disabilities

Elder Abuse Task Force Recommendations - TBD

Adult Protective Services Technology Investment - \$1 million

AAA Expenditures - \$3.75 million

- \$2.5 million – Older American Act support due to sequestration cuts
- \$1.25 million - Restoration of nutritional programs and evidence based health promotion and disease prevention programs

Total - \$23.567 million
