The LeadingAge Oregon 2019 Ageless Art program will be held on August 15, 2019. We're looking forward to all of our member communities participating. Due to the nature of this program, there are policies and procedures that must be followed to ensure the safety of the art and to facilitate a successful viewing, judging and exhibit. **Please read over the entire packet** before sharing this information with your residents.

# **Eligibility and Entering the Art Competition**

- 1. The Ageless Art contest is open to all residents of LeadingAge Oregon member facilities who are **60 years** and older. One entry per person.
- 2. The art must have been completed within the last 10 years and after the artist turned 60 years old.
- 3. An art entry form must be submitted for each piece of art entered along with a digital photo (see below for more information).
- 4. All art entry forms, completed in full, must be received in the LeadingAge Oregon office by July 26, 2019.
- 5. For the entry to be included in the viewing and judging, the "Entry Description" portion of the entry form must be completed (this is necessary so that we insure your facility has been allocated enough space for each of your entries); along with a digital photo submitted of the artwork suitable for placement in the program's PowerPoint presentation. You must upload your photo in the form prior to submitting. Name your attachment as follows: organization's name with artist last name. For example: Leadingageoregon-Goewey. This will help put the presentation together efficiently in our limited time between judging and program presentation.

### Displaying and Judging the Art at Rose Villa Senior Living Community

- 1. We must have display cards for each item. Display cards must be printed on **white card stock** (not foam core) with all the information shown on the following example included, **exactly as specified and shown**. This is necessary so that pieces have attractive and consistent cards with descriptions. Please use Times New Roman, 14 pt font.
- 2. NO floor easels are allowed due to limited floor space. Please provide as many table easels as you can. Quilts will be hung as space permits, otherwise they will be draped over pieces of furniture or set on tables.
- 3. All artwork must arrive at Rose Villa Senior Living on August 15, 2019 and set up by 9:15 a.m. for judging at 9:30 a.m.

#### **General Policies:**

IF THE ENTRY IS A PAINTING, PHOTOGRAPH OR ANY OTHER MATTED ARTWORK: To be ready for display, paintings, photographs and any matted artwork must be framed, matted and ready for hanging with hanging wire on the back of the picture or it will not be displayed. For the exhibit at Rose Villa Senior Living Community please provide your own table easels for display.

IF THE ENTRY IS A QUILT: Please baste loops or a "sleeve" (large enough to easily fit a **two-inch** dowel through) on the top of the back of the quilt so we can slip it onto a dowel for display, space permitted. **Quilts** without loops or sleeves will not be displayed.

The top ten "Judges Choice" Artists will receive a Judges Choice ribbon, other artists whose work is chosen for exhibit will receive a certificate acknowledging their achievement.
