# A1 AI in Aging Services

## Presenter: Scott Cod, LeadingAge, and Adam Arker, Hartman Executive Advisors

Lesley and Marci will also discuss the "Hopewell Wheel of Care" and how it supports living well in the presence of death and dying.

# A3 Strategies for Building Sustainable Organizations

### Presenter: Mary Muñoz, Ziegler

Prior to the COVID pandemic, housing, care and service providers for older adults were beginning to consolidate, with an increasing number of transactions over the past ten years. COVID accelerated this activity, as providers across the country saw increased stress, especially in skilled nursing. Additionally, areas of operating weakness were magnified during COVID; labor shortages were magnified as well, and in some cases, employees are not coming back. These factors have led to financial stress across many organizations stemming from concurrent depressed revenue and increased expenses, especially salary and benefits.

Some organizations are able to maneuver through these troubled waters to improve profitability. Other organizations have opted to reposition their portfolios, divesting of non-core assets or reducing the size/closing certain levels of care. Some weaker organizations have asked to join stronger organizations. Others have entered into strategic partnerships to diversify service mix, share risk, bring outside perspective, or bring new management. Still others have faced bankruptcy or closure.

This session examines the key characteristics of sustainable business models and strategies organizations can take if they determine their current models are not sustainable.

# B1 Nightmare on Survey Street: Strategies to Manage the CBC Survey and Enforcement Process

### Presenters: Gabriela Sanchez and Jeff Duncan, Lane Powell

This session examines the Nursing Home survey and enforcement process, including the roles of DHS and CMS. Using real world examples, the presenters guide you through how to interact with surveyors, how to manage the dreaded immediate jeopardy tag, when to request an IDR versus an I-IDR (and how those processes generally function in reality), and when to request a formal hearing with the Federal Departmental Appeals Board instead of accepting a 33% of discount. Strategies for reducing civil monetary by 50% penalties when you self-report are discussed. Additionally, learn about NATCEP waivers and the impact of civil monetary penalties on your ability to conduct nursing training programs at your communities.

# B2 Oregon Housing & Community Services Updates

### Presenters: Sara Carrillo and Eva Luna, Oregon Housing and Community Services

This session provides an overview of the HUD contract administration section at Oregon Housing and Community Services and provide some agency updates. Presenters also provide a brief update on some of the recent HUD changes such as HOTMA, contract renewals, streamlining management and occupancy reviews and answer any questions you may have.

APD has identified goals of well-being, accessibility, quality outcomes, service equity, and engagement to support the vision they have that Oregon's older adults, people with disabilities and their families experience person-centered services, supports and early interventions that are innovative and help maintain independence, promote safety, wellbeing, honor choice, respect cultural preferences and uphold dignity. Learn more about how state strategies may affect your organization's operations, your staff, your residents and clients, and Oregon's system of long-term services and supports.

# C2 10 Things You Hate About the SNF Survey Process and What you Can Do About It

### Presenters: Gabriela Sanchez and Jeff Duncan, Lane Powell

This session takes a deep dive into the Community Based Care survey and enforcement process. The presenters guide you through the entire enforcement cycle, sharing best practices along the way. This includes management of informal conferences, including the formal hearing process. Real world examples are shared as part of a discussion on how the survey process works, best practices for interactions with surveyors and APS investigators, what do to when you receive your survey results, and when to request an informal conference. Learn how APS' investigations fit into this equation and how substantiated findings of abuse may affect your ability to retain your care staff. In addition, understand the different penalties and when to request a formal hearing – and steps to help increase your chances of a successful appeal or of reaching an appropriate negotiated resolution.

# C3 Mental Health Services in Senior Living

### Presenter: Evan Alvord, Rogue Psych Consultants LLC

Mental health concerns are common among seniors and include isolation, anxiety disorders, dementia, and psychosis, among others. Discover how mental health services are being integrated into some communities and how these services can support providers in addressing a range of issues including: diagnostic clarification; behavioral management techniques; psychotropic medication reviews; and risk management. Mental health support and interventions can lower hospitalization rates; aid in regulatory compliance, and improve staff's ability to provide effective care. During this interactive session we want to hear the barriers and challenges you face in supporting older adults and meeting their behavioral and mental health needs; and discuss steps providers can take to improve better care and outcomes for their residents.
