Oregon Office of Emergency Management & PPE

Earlier today we asked licensed senior care living communities whether they had an adequate supply of PPE because of the intent of <u>Oregon's Emergency Coordinator Center</u> (ECC) under the <u>Oregon Office of</u> <u>Emergency Management</u> (OEM) to allocate boxes of PPE to those who do not. We will keep you posted on timeline and specifics.

In response to Governor Brown's COVID-19 Executive Order a few weeks ago, the OEM mobilized the ECC to coordinate and support state and local recovery efforts. The ECC is collaborating with the Oregon Health Authority (OHA) and its Agency Operations Center (AOC). OHA serves as the lead agency for public health response efforts and the ECC is focused on minimizing any disruption to critical services in Oregon. CMS Provides Additional Information for Transfers Based on COVID-19 Status

CMS is providing supplemental information for transferring or discharging residents between facilities for the purpose of cohorting residents based on COVID-19 status (i.e., positive, negative, unknown/under observation).

In general, if two or more certified LTC facilities want to transfer or discharge residents between themselves for the purposes of cohorting, they do not need any additional approval to do so. However, if a certified LTC facility would like to transfer or discharge residents to a non-certified location for the purposes of cohorting, they need approval from the State Agency.
