# January 8, 2020 - Session 1 Build & Implement Crucial PDPM Policies

This introductory session of the PDPM Master Class Series includes an in-depth discussion of the importance of developing and implementing key skilled nursing facility (SNF) policies and procedures to ensure compliance under PDPM. Participants will gain insight into areas where PDPM specific policies and procedures are recommended with a focus on facility processes that promote consistently accurate, patient-driven data collection methods, assessment practices, interdisciplinary team collaboration for coding, and quality oversight mechanisms. This session will provide guidance on suggested areas of SNF policy development with examples of effective process considerations and policy language for PDPM risk areas including the Interim Payment Assessment (IPA), Interrupted Stay rule and Therapy Delivery under PDPM.

#### February 5, 2020 - Session 2

#### Getting the PDPM Initial PPS Assessment Right!

This session of the PDPM Master Class Series will focus on best practices for data collection from pre-admission screening through day eight of the SNF stay. This webinar will review effective systems and suggested timeframes for resident assessment through an Interdisciplinary approach to ensure accurate and timely information is gathered to appropriately report care and services provided on the initial Medicare assessment. Emphasis will be on critical data elements used in the calculation of the PDPM per diem. The RAI MDS Correction Policy will also be reviewed to ensure the appropriate correction of errors should they be identified.

#### March 4, 2020 - Session 3

#### Applying Dollar Values to PDPM Characteristics & Avoiding Top Missed Opportunities

This session of the PDPM Master Class Series will focus on the financial implications of coding (or failing to code) various PDPM characteristics through a review of high-risk variables impacting PDPM reimbursement. Actual PDPM audit trends and case studies will be reviewed to identify areas of potential missed opportunity, process lapses, and supportive documentation vulnerabilities. Operational strategies to promote PDPM compliance and coding accuracy in high impact areas will be emphasized.

# April 1, 2020 - Session 4 Effective Meetings for PDPM

This session of the PDPM Master Class Series will review how daily clinical, Medicare, and triple-check meeting processes can be updated to ensure ongoing resident-centered assessment and identification of changes under PDPM. Best practices for review of newly admitted residents, incorporating IPA considerations, Interrupted Stay tracking, and assurance of continued skilled need will be emphasized along with ensuring clean claims through an effective presubmission review process.

#### May 6, 2020 - Session 5

#### PDPM: Staff Development and Core Competency Essentials

This session of the PDPM Master Class Series will review essential competencies for PDPM success including, but not limited to, ICD-10 coding, Section GG assessment, and MDS coding with special focus on nursing clinical competencies to identify, assess, and manage Nursing and NTA conditions and services. Suggested processes for evaluating facility level of competency in certain areas will be reviewed while creating effective staff development processes for initial and ongoing education, skills development, and cross-training to avoid gaps in competency related to employee turn-over will be emphasized.

#### June 3, 2020 - Session 6

#### Care Planning for the Complex Resident Under PDPM

This session of the PDPM Master Class Series will review regulatory requirements related to Baseline and Comprehensive care planning with focus on developing effective person-centered care plans that address complex care and services provided. This webinar will focus on ensuring appropriate care plan development related to the resident's SNF admitting diagnosis and PDPM Clinical Category, comorbid conditions, and skilled services provided to promote positive resident outcomes and support coding decisions on the initial Medicare assessment.

#### July 8, 2020 - Session 7

#### All In! PDPM Supportive Documentation for Physicians, Nursing, Rehab, Dietary, and Social Services

This session of the PDPM Master Class Series will focus on interdisciplinary team documentation requirements and best practices as it relates to PDPM. The webinar will include review of skilled level of care criteria with an emphasis on supporting the skilled stay and coding that impacts reimbursement of skilled SNF services under the Patient Driven Payment Model (PDPM). Emphasis will be on understanding the critical role of the Physician, Nurse, Therapist, Dietary, and Social Services in supportive documentation for key areas impacting PDPM payment, and in driving facility documentation quality.

#### August 8, 2020 - Session 8

#### PDPM Quality Assurance and Outcomes Tracking

A review of Key Performance Indicators and strategies for data collection, monitoring and applying outcome measures to drive continual quality assurance will be discussed. Examples of business intelligence reporting and implications for operations will be included.

#### September 2, 2020 - Session 9

#### Addressing PDPM Medical Review Risks in the SNF Compliance & Ethics Work Plan

This session of the PDPM Master Class Series will focus on PDPM Medical Review risks for providers and key strategies to address those risks in the Compliance and Ethics Work Plan. The webinar will emphasize risks related to supporting daily skilled services, medical necessity, MDS coding decisions impacting reimbursement (e.g. modified diets, NTA items, etc.), therapy service provision patterns including the volume and mode of treatment and justifying functional patient outcomes. Strategies for driving ethical practice and facility compliance through a targeted work plan that addresses Medical Review risks will be emphasized.

#### October 7, 2020 - Session 10

#### PDPM: Advancing Clinical Capabilities and Care Delivery

Focus of this webinar will be on strengthening or developing care delivery processes by way of evaluating the opportunity for clinical programs, marketing clinical scope, and assuring success through facility policy, OAPI, and Facility Assessment review.
